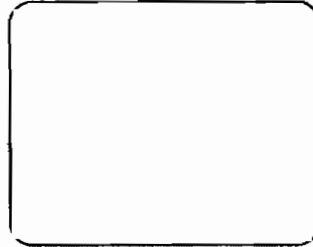

CALLING OF ELECTIONS FOR THE PROVINCIAL HOUSE OF TRADITIONAL LEADERS, DETERMINATION OF THE NUMBER OF MEMBERS OF THE PROVINCIAL HOUSE, AND THE DETERMINATION OF THE PROCEDURE TO BE FOLLOWED AT THE ELECTION OF MEMBERS OF THE PROVINCIAL HOUSE OF TRADITIONAL LEADERS

1. Section 37 of the Northern Cape Traditional Leadership, Governance and Houses of Traditional Leaders Act 2007 (Act No. 2 of 2007) establishes Provincial House of Traditional Leaders in the Province of the Northern Cape. Pursuant thereto I, **Grizelda Boniwe Cjiekella**, in my capacity as Acting Premier of the Northern Cape –
 - 1.1 In terms of **section 37(2)** of Act No. 2 of 2007, hereby call for the election of members of the Provincial House of traditional leaders in the Province of the Northern Cape,
 - 1.2 In terms of **section 37(2) (iii)** hereby appoint the Independent Electoral Commission to chair the election of members the Provincial house of traditional leaders in the Province of the Northern Cape.
 - 1.3 In terms of **section 37(1)** of Act No. 2 of 2007, and after consultation with the Electoral College of senior traditional leaders in the Province of the Northern Cape, hereby determine that the number of the members of the Provincial House of Traditional Leaders must be a total of 12 members. Eight Senior Traditional Leaders will be elected by the Electoral College, two members will be elected from Local House of Traditional Leaders, and two members will be elected from the remainder of traditional Leaders not elected to the Local House of Traditional Leaders.
 - 1.4 In terms of **section 37 (3)** of Act No. 2 of 2007 hereby determine that the procedure to be followed at the election of members of the Provincial House of the Traditional Leaders must be as follows:

(a) by way of secret ballot,

(b) conducted by the Independent Electoral Commission as the person, not forming part of the electoral college, designated by myself in terms of section 37(2)(iii) of Act No.2 of 2007 to preside over the proceedings of the electoral college in a manner that is impartial and in terms of a fair process,

(c) the person designated in terms of sub-paragraph (b) above must compile and submit to myself a detailed report including-

- a copy of the meeting and agenda,
- a copy of the attendance register,
- a copy of acknowledgement(s) by a member to take part in any nominations or elections to the local house,
- a copy of the minutes of the meeting,
- copies of certificate of recognition of traditional leaders attending such meeting,
- a full report on the elections or nominations of persons to the local house, and
- the names of members elected to the local house of traditional leaders.

(d) any member of the electoral college may lodge a dispute regarding any substantive or procedural matter regarding election or nomination of persons to the Provincial house of traditional leaders with the presiding officer designated by the premier as indicted above at sub-paragraph (b), and

(e) if a member of the electoral college is not satisfied with the decision of the presiding officer after lodging a complaint in terms of sub-paragraph (d) such member may appeal to the Premier as the executing authority.

(f) the elections will be finalized when all the members of the electoral college accepts the results or once all disputes and/or appeals regarding the elections have been decided on.

2. The elections contemplated under 1.1, above, shall be held as follows:
 - 2.1 **Venue:** **Northern Cape Provincial Legislature**
 - 2.2 **Date:** **Thursday, 25th May 2012**
 - 2.3 **Time:** **10h00 am.**

DETERMINATION OF THE NUMBER OF MEMBERS OF THE LOCAL HOUSES, AND
THE DETERMINATION OF THE PROCEDURE TO BE FOLLOWED AT THE ELECTION
OF MEMBERS OF THE LOCAL HOUSES OF TRADITIONAL LEADERS**

1. Section 43 of the Northern Cape Traditional Leadership, Governance and Houses of Traditional Leaders Act 2007 (Act No. 2 of 2007) establishes Local Houses of Traditional Leaders in the district municipalities where traditional communities exist. Pursuant thereto I, **Grizelda Boniwe Cjiekella**, in my capacity as Acting Premier of the Northern Cape -
 - 1.1 In terms of **section 44 (3)** of Act No. 2 of 2007, hereby call for the election of members of a Local House of traditional leaders in the John Taole Gaitsewe district Municipality.
 - 1.2 In terms of **section 44(2)(iii)** hereby appoint the Independent Electoral Commission to chair the election of members the Local House of traditional leaders in the John Taole Gaitsewe District Municipality.
 - 1.3 In terms of **section 44 (1)** of Act No. 2 of 2007, and after consultation with the electoral college of senior traditional leaders for the District of John Taole Gaitsewe, hereby determine that the number of the members of the Local House of Traditional Leaders must be a total of 7 members elected in terms of a formula described below as follows:

1.4 In terms of **section 44 (4)** of Act No. 2 of 2007 hereby determine that the procedure to be followed at the election of members of the Local Houses of the Traditional Leaders must be as follows:

(a) by way of secret ballot,

(b) conducted by an independent person, not forming part of the electoral college, designated by myself in terms of section 44(2)(iii) of Act No.2 of 2007 to preside over the proceedings of the electoral college in a manner that is impartial and in terms of a fair process,

(c) the person designated in terms of sub-paragraph (b) above must compile and submit to myself a detailed report including-

- a copy of the meeting and agenda,
- a copy of the attendance register,

- a copy of acknowledgement(s) by a member to take part in any nominations or elections to the local house,
- a copy of the minutes of the meeting,
- copies of certificate of recognition of traditional leaders attending such meeting,
- a full report on the elections or nominations of persons to the local house, and
- the names of members elected to the local house of traditional leaders.

(d) any member of the electoral college may lodge a dispute regarding any substantive or procedural matter regarding election or nomination of persons to the local house of traditional leaders with the presiding officer designated by the premier as indicated above at sub-paragraph (b), and

(e) if a member of the electoral college is not satisfied with the decision of the presiding officer after lodging a complaint in terms of sub-paragraph (d) such member may appeal directly to the Premier as the executing authority.

(f) the elections will be finalized when all the members of the electoral college accepts the results or once all disputes and/or appeals regarding the elections have been decided on.

2.2 **Date:** **Thursday, 24th May 2012**

2.3 **Time:** **10h00 am.**
