COMMISSION TO INQUIRE INTO THE DESIRABILITY, OR OTHERWISE, OF THE AUTHORIZATION, UNDER SECTION 3 (1) OF THE HORSE-RACING AND BETTING ORDINANCE, 1978 (ORDINANCE No. 24 OF 1978), FOR THE ISSUE OF A LICENCE TO PRETORIA TURF CLUB TO HOLD RACE-MEETINGS ON THE LAND SITUATED AT PORTION 48 OF THE FARM RANDJESFONTEIN 405, REGISTRATION DIVISION JR, TRANSVAAL

The Administrator has under section 2 (1), read with sections 3 and 4, of the Commissions of Inquiry Ordinance, 1960 (Ordinance No. 9 of 1960), appointed a commission, consisting of **Mr J. A. Crafford** (who has been designated as the chairman of the commission) and **Mr R. J. Falkson**, to inquire into the desirability, or otherwise, of the authorization under section 3 (1) of the Horse-racing and Betting Ordinance, 1978 (Ordinance No. 24 of 1978), for the issue of a licence to Pretoria Turf Club to hold race-meetings on the land situated at Portion 48 of the farm Randjesfontein 405, Registration Division JR, Transvaal, with special reference to the effect that the issue of such licence may have on—

- (i) the horse-racing industry in the Transvaal;
- (ii) the existing horse-racing facilities in the Transvaal;
- (iii) the revenue accruing to the Account for Provincial Services: Transvaal in terms of the last-mentioned Ordinance; and
- (iv) the Horse-racing Development Fund.
