FORMAL PROTECTION OF ARCHAEOLOGICAL SITES, LANDSCAPE AND NATURAL FEATURES OF CULTURAL SIGNIFICANCE, STRUCTURES AND UNMARKED BURIALS, SITUATED ON OR AT THE "OLD GRANARY COMPLEX", SITUATED ON ERF 177447, CAPE TOWN

By virtue of the powers vested in Heritage Western Cape, as the provincial heritage resources authority for the province of the Western Cape, in terms of section 27(2) of the National Heritage Resources Act, Act no. 25 of 1999, archaeological and palaeontological sites, unmarked burials, the landscape and natural features of cultural significance and structures situated on or at Erf 177447, Cape Town, corresponding with number 11 Buitenkant Street, Cape Town and as reflected in the below schedule, are hereby formally protected under section 27 of the Act bearing the provisions of sections 34, 35 and 36 of the Act in mind.

HERITAGE WESTERN CAPE**DECLARATION OF HERITAGE RESOURCES AS PROVINCIAL HERITAGE, "OLD GRANARY COMPLEX" IN CAPE TOWN.**

In terms of section 27 of the National Heritage Resources Act, No. 25 of 1999, Heritage Western Cape hereby declares the Old Granary Complex, fully described in the schedule, as a Provincial Heritage Site.

Schedule

The demarcation of the Provincial Heritage Site is as follows:

Number 11 Buitenkant Street on Erf 177447 in Cape Town, as described in the SG Diagram No. 256/2015.

Significance

The building known as The Old Granary was constructed in the early 1800's and is, in part, the work of recognised master craftsmen of the time, one being sculptor Anton Anreith who was responsible for the pediment and statues of Neptune and Britannia. The front portion of the building contains elements of major architectural and aesthetic significance.

The property represents a rare historical record of largely undisturbed development and use over a major length of time where it served initially as a dwelling house after which it was purchased by the British colonial government for use as a Customs House, probably because of its proximity to the Castle, where the original customs house was located. Subsequently the use was changed to that of a Granary or grain store.

Situated next to the original *justicie plaats* the property also has great historical significance associated with the enforcement of public order in a predominantly colonialist era of government where it served as both a Magistrate's Court and a prison (House of Correction) for women.

The Old Granary complex is regarded as an important complex of buildings of the colonial period in the Province, in terms of both architectural and social significance.

Kragtens die bevoegdheid verleen aan Erfenis Wes-Kaap, as die provinsiale erfenishulpbronne gesag van die Wes-Kaap, ingevolge artikel 27(2) van die Wet op Nasionale Erfenishulpbronne, Wet no. 25 van 1999, word die argeologiese en die paleontologiese terreine, ongemerkte grafte, die landskap en natuureienskappe van kulturele betekenis en strukture op of by Erf 177447, Kaapstad, wat ooreenstem met Buitenkant Straat 11, Kaapstad, en soos in die bylae hieronder aangetoon, hierby formeel beskerm ingevolge artikel 27 van die Wet, met inagneming van die bepallings van artikels 34, 35 en 36 van die Wet.

ERFENIS WES-KAAP**VERKLARING VAN ERFENISHULPBRONNE AS PROVINSIALE ERFENIS, "OLD GRANARY KOMPLEKS" IN KAAPSTAD.**

Ingevolge artikel 27 van die Wet op Nasionale Erfenishulpbronne, No. 25 van 1999, verklaar Erfenis Wes-Kaap hierby die Old Granary Kompleks, volledig beskryf in die bylae, as 'n Provinsiale Erfenisterrein.

Bylae

Die afbakening van die Provinsiale Erfenisterrein is soos volg:

Buitenkant Straat nommer 11 op Erf 177447 in Kaapstad, soos beskryf in die LG-diagram No. 256/2015.

Betekenis

Die Old Granary gebou is in die vroeë 1800's opgerig en 'n deel daarvan is die werk van meester-ambagsmanne van daardie era. Een van hulle was die beeldhouer Anton Anreith wat verantwoordelik was vir die pediment en standbeelde van Neptune en Britannia. Die voorste gedeelte van die gebou bevat elemente van groot argitektoniese en estetiese betekenis.

Die eiendom is 'n baie goeie voorbeeld van 'n seldsame historiese rekord van hoofsaaklik ongerepte ontwikkeling en gebruik oor 'n lang tydperk, waar dit aanvanklik as 'n woonhuis gebruik en toe daarna deur die Britse koloniale regering gekoop is om as 'n Doeane-kantoor gebruik te word, waarskynlik omdat dit so naby aan die Kasteel (waar die oorspronklike Doeane-kantoor geleë was) was. Daarna is daar besluit om dit as 'n Graanskuur te gebruik.

Die eiendom is langs die oorspronklike *justicie plaats* geleë en dit het ook groot historiese betekenis wat geassosieer word met die handhawing van openbare orde in 'n oorwegend kolonialistiese tydperk van regering waar dit as beide 'n Landdroshof en 'n tronk (ôHouse of Correctionô) vir vroue gedien het.

Die Old Granary kompleks word beskou as 'n belangrike kompleks van geboue van die koloniale tydperk in die Provinsie, wat betref beide argitektoniese en maatskaplike betekenis.
