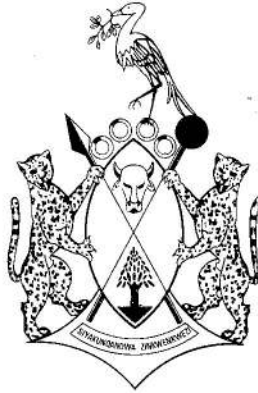

# ADDITIONAL APPROPRIATION ACT, 1988

## A C T

To appropriate an additional amount of money for the requirements of the Republic of Ciskei during the financial year ending 31 March, 1988.

(English text signed by the President. Assented to on 21 July 1988.)

*BE IT ENACTED by the National Assembly of the Republic of Ciskei as follows:-*

**1. Appropriation of additional amount of money for the requirements of Republic of Ciskei.** - Subject to the provisions of the Exchequer and Audit Act 1985 (Act No. 28 of 1985) there is hereby appropriated for the requirements of Republic of Ciskei during the financial year ending 31 March, 1988 the additional amount of money shown in Column 1 of the Schedule with which the Revenue Fund of Ciskei shall be charged.

**2. Short title.** - This Act shall be called the Additional Appropriation Act, 1988.
