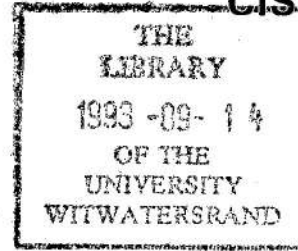
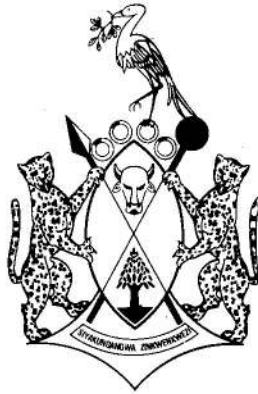

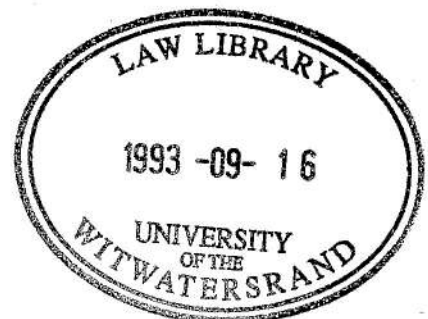

# COUNCIL OF STATE — REPUBLIC OF CISKEI

## LIQUOR AMENDMENT DECREE, 1993

### DECREE

To amend the Liquor Act, 1983.

*[English text signed by the Chairman of the Council of State. Assented to on 31 July 1993.]*

BE IT DECREED by the Council of State of the Republic of Ciskei, as follows: -

**1. Amendment of section 1 of Act 13 of 1983, as amended by section 1 of Act 23 of 1984, section 1 of Act 3 of 1985, section 1 of Act 29 of 1985 and section 1 of Decree 27 of 1990.** — Section 1 of the Liquor Act, 1983 (hereinafter referred to as the principal Act) is hereby amended -

(a) by the substitution for the definition of "association of persons" of the following definition:

"'association of persons' means a company, close corporation, society, partnership or other association of persons;"

(b) by the insertion after the definition of "Ciskei" of the following definition:

"'close corporation' means a close corporation which is registered in Ciskei;"

(c) by the substitution for paragraph (a) of the definition of "closed day" of the following paragraph:

"(a) means a Sunday, Good Friday, Ascension Day, Day of the Vow and Christmas Day;"

(d) by the deletion of the definition of "polling day"; and

(e) by the substitution for the definition of "Tourist Authority" of the following definition:  
"'Tourist Authority' means any authority established by the State for the promotion of tourism in Ciskei;"

**2. Amendment of section 10 of Act 13 of 1983, as amended by section 3 of Act 29 of 1986 and section 2 of Decree 27 of 1990.** - Section 10 of the principal Act is hereby amended by the substitution for paragraph (c) of subsection (1) of the following paragraph:

"(c) at any meeting, any application or other matter whatsoever which the Minister may refer to that meeting but subject to compliance by the applicant with the provisions of section 23(2) or 26, as the case may be, in any application to which those provisions apply."

**3. Substitution of section 23 of Act 13 of 1983.** - The following section is hereby substituted for section 23 of the principal Act:

"23. Application for renewal of licence. - (1) An application for the renewal of a licence (other than a temporary liquor licence or a late hours' licence) shall -

(a) be substantially in the prescribed form; and

(b) subject to the provisions of subsection (2), be lodged with the Director-General on or before 1 September of the year in respect of which the licence to which such application relates was issued.

(2) Notwithstanding the provisions of paragraph (b) of subsection (1), an application for the renewal of a licence may be lodged with the Director-General -

(a) not later than 10 September, upon payment by the applicant of a fee of twenty rand; and

(b) at any time after 10 September but not later than 30 September, upon payment by the applicant of a fee of two hundred rand."

**4. Amendment of section 32 of Act 13 of 1983, as amended by section 2 of Act 23 of 1984.** - Section 32 of the principal Act is hereby amended by the insertion in subsection (1) of the following paragraph:

"(b) any person who is in default with the payment of any tax or fee which, under any law, is or is deemed to be a debt due to the State; or"

**5. Short title.** - This decree shall be called the Liquor Amendment Decree, 1993.
