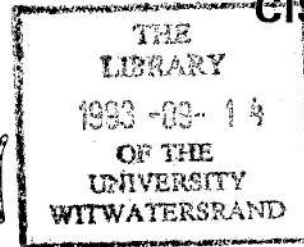
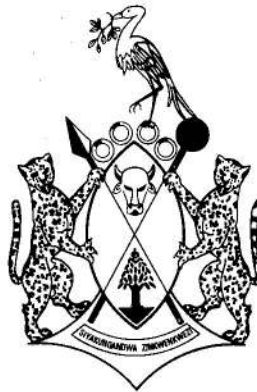

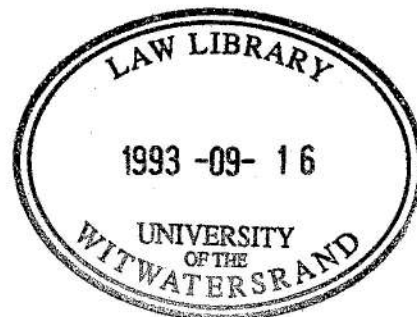

Government Service Pensions Amendment Decree, 1993 (Decree 9 of 1993): Termination of appointment of member and chairman of board of Trustees of Ciskeian Civil Servants Pension Fund

PROCLAMATION No. 7 OF 1993

by the Chairman of the Council of State of the Republic of Ciskei

GOVERNMENT SERVICE PENSIONS AMENDMENT DECREE, 1993 (DECREE 9 OF 1993);
TERMINATION OF APPOINTMENT OF MEMBER AND CHAIRMAN OF BOARD OF TRUSTEES
OF CISKEIAN CIVIL SERVANTS PENSION FUND

WHEREAS Vice-admiral Marthinus Albertus Bekker, then the Minister of Finance and Economic Development, was on 18 June 1993 appointed as member and chairman of the Board of Trustees of the Ciskeian Civil Servants Pension Fund in terms of section 2D(1) of the Government Service Pensions Amendment Decree, 1993:

AND WHEREAS the said Marthinus Albertus Bekker has ceased to be a Minister of State of the Republic of Ciskei:

AND WHEREAS the tenure of the aforesaid offices by the said Marthinus Albertus Bekker is giving rise to administrative difficulty in the application of the laws relating to the aforementioned Ciskeian Civil Servants Pension Fund, by reason of the fact that he is no longer Minister of Finance and Economic Development.

NOW, THEREFORE, under and by virtue of the powers vested in me by section 37(3) of the Republic of Ciskei Constitution Decree, 1990 (Decree 45 of 1990), I do hereby declare that, with effect from the date of publication of this Proclamation -

- (a) the appointment of Vice-admiral Marthinus Albertus Bekker as member and chairman of the Board of Trustees of the Ciskei Civil Servants Pension Fund shall be and is hereby terminated; and
- (b) the rules of the Ciskeian Civil Servants Pension Fund published in Government Notice No. 43 of 1993 are hereby amended as set out in the Schedule to this Proclamation.

Given under my Hand and the Seal of the Republic of Ciskei at Bisho on this eleventh day of August One thousand Nine hundred and Ninety-three.

SCHEDULE

Government Notice No. 43 of 8 June 1993 amended -

- (a) by the substitution of rule 1.17 of the following rule:
"1.17 **'Minister'** the person holding office for the time being as Minister of Finance and Economic Development or any other Minister of State appointed by the Head of State as the alternate of such firstmentioned Minister or otherwise to act in his stead;"
- (b) by the substitution for rule 4.1.2 of the following rule:
"4.1.2 Subject to the provisions of rule 4.1.5, the first trustees appointed by the Minister in terms of section 2D(1) of the Government Service Pensions Decree, 1993 (Decree 9 of 1993) shall hold office for a period of twelve months. Should any such trustee (other than the Minister) cease to be a trustee for whatever reason, the Minister shall appoint a replacement trustee whose term of office shall expire when the term of office of the trustee in whose place he was appointed, would have expired."; and

(c) by the substitution for rule 4.1.5 of the following rule:

"4.1.5 The Minister shall act as the first chairman of the Board and as trustee in accordance with the provisions of Government Notice No. 45 of 1993. The term of office as a trustee and as chairman of the Board of the Minister shall terminate at the earlier of the following occurrences, namely -

- (a) such Minister's resignation from the Board or if he dies or his appointment as Minister of State is terminated in any other way;
- (b) a decision by the Board to such effect: Provided that such a decision may not be taken within the period of 12 months after the transition date.

The Board shall thereafter appoint a chairman for the Board, hereinafter referred to as the chairman, for such duration as decided by the Board."
