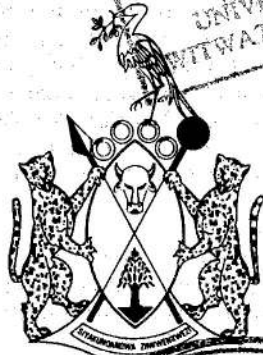

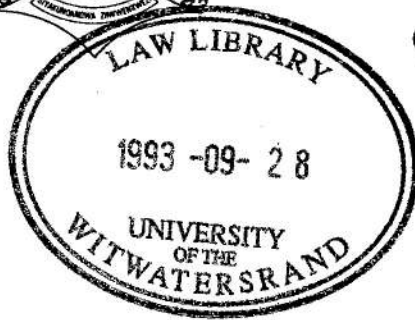

### NOTICE OF INTENT TO APPLY FOR A LOAN

Notice is hereby given in terms of Section 95 of the Municipal Act of 1987 that the Whittlesea Town Council intends to apply to the Department of Internal Affairs and Land Tenure to raise an internal loan of R43 890. The purpose of the loan is to enable Consulting Engineers to carry out a preliminary investigation into water and sewer reticulation of existing properties, taxi rank and hawker facilities, Municipal office accommodation, and proposed subdivision of municipal property. The effect of this loan on the ratepayers of Whittlesea will be an additional monthly levy of 0.02 cents (zero comma zero two cents) per Rand of property value.

Objections, if any, to the above must be lodged in writing with the Town Clerk, Whittlesea, at the Municipal Offices, Caldewood Street, Whittlesea, within twenty one days of publication of this notice, quoting the objector's erf number and street address.
