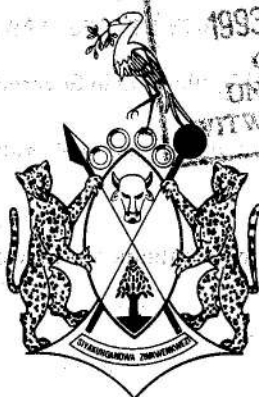

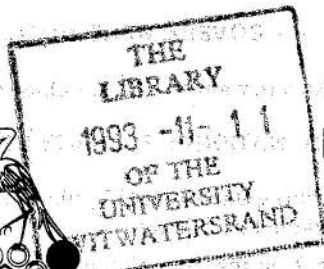

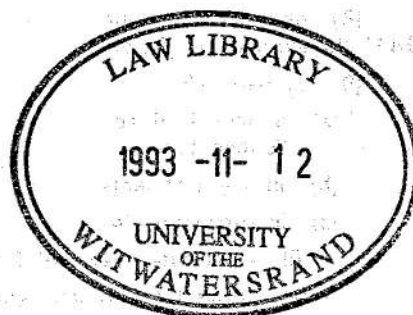

GOVERNMENT NOTICE No. 87 OF 1993

The following Government Notice is published for general information:

CORRECTION: NATIONAL SECURITY DECREE, 1993 (DECREE 19 OF 1993)

The National Security Decree, 1993 published in Government Gazette 103 of 3 September 1993 is hereby corrected as follows:

(1) On page 2, in the definition of "this decree", substitute for the word "provisions" the word "provision";

(2) on page 3 -

(a) in line 1 of section 2(1)(d) substitute for the words "of any" the words "or any";

(b) in section 3 substitute the following paragraph (b):

"(b) cripples, prejudices or interrupts any industry or undertaking, or industries or undertakings generally, or the production, supply or distribution of commodities or foodstuffs or attempts to do so, or";

(3) on page 4 -

(a) in line 3 of subparagraph (ii) - the concluding paragraph - of section 3 substitute for the word "Act" the word "act";

(b) in line 2 of paragraph (f)(iii) of section 4, substitute for the word "commissioner" the word "commission".

(4) on page 5 -

(a) in line 4 of section 5, substitute for the words "or any" the words "of any";

(b) in line 1 of section 7 substitute for the word "indicated" the word "indicates";

(c) in line 3 of section 8(1)(b) substitute "disturbance" for "distrubance";

(5) on page 8 -

(a) in section 12(1)(a) substitute for the word "sections" the word "section";

(b) substitute the following for subparagraph (ii) appearing towards the end of section 12(1):

"(ii) in the case of an offence referred to in paragraph (b) or (c), to imprisonment for a period not exceeding three years, and";

(6) on page 9, in the last but one line of subsection (1), substitute for the expression "subsection 3(a)" the expression "subsection (3)(a)";

(7) on page 10 -

(a) in the last line of section 13(3)(d)(ii) substitute "*alteram*" for "*alieram*";

(b) in line 1 of that part of section 14(1) following paragraph (c) substitute "declare" for "decalre";

(8) on page 11, in line 3 of section 15(3), substitute for the expression "Defence Act, 1981" the expression "Defence Act, 1986";

(9) on page 12 -

(a) in line 1 of section 16(2), substitute for the word "subsections" the word "subsection";

(b) in line 3 of section 17(1) substitute "occurring" for "occuring";

(c) in subsection (4) of section 17 -

(i) substitute "*Gazette*" for "*Gaqzette*" in line 2;

(ii) substitute "to" for "kto" in line 3;

(iii) substitute "intimidation" for "iontimidation" in line 7;

(10) on page 13 -

(a) in section 18 in the definition of "unlawful gathering", substitute the expression "19(1)" for the expression "18(1)" in line 1 of subparagraph (i);

- (b) in line 1 of paragraph (b) of section 19(1) substitute for the words "that nature" the words "the nature";
- (11) on page 17, in line 1 of section 29(2) - at the bottom of the page - substitute for the words "the prosecution" the words "any prosecution";
- (12) on page 18, in the last line of section 30(4), substitute for the words "or any" the words "of any";
- (13) on page 21, in the last line but one of section 37(2) - at the bottom of the page - substitute the word "rand" for the word "rant";
- (14) on page 22, in line 3 of section 38 - at the top of the page - substitute the word "purpose" for the word "prupose";
- (15) on page 23 -
 - (a) in line 3 paragraph (c) of section 40, substitute the expression "presence of," for "presence";
 - (b) in the heading of section 44 substitute the expression "44. Certain persons may be charged jointly" in ordinary type for the expression "44. Certain person may be charged jointly" appearing in italics;
- (16) on page 24 -
 - (a) in that part of section 44 following paragraph (b) substitute for the word "person" the word "persons";
 - (b) in line 3 of section 45 substitute for the word "proceedings" the word "proceeding";
 - (c) in line 4 of subsection (1) of section 46 substitute "institution" for "ionstitution";
 - (d) in line 3 of paragraph (a) of section 48 substitute for the word "officer-bearer" the word "office-bearer";
- (17) on page 26, in line 1 of subsection (2) of section 53 substitute for the word "for" the "For";
- (18) on page 27 -
 - (a) in line 5 of subsection (3) of section 53 (at the top of the page) substitute "obtained" "obtaioned";
 - (b) in line 1 of subsection (1) of section 55 substitute for the word "statue" the word "statute";
 - (c) in the whole of subsections (1) and (2) of section 55 substitute ordinary type for the bold type (i.e. except for the heading);
 - (d) in line 4 of subsection (1) of section 56 substitute "transporation" for "transportation";
- (19) on page 28 -
 - (a) in line 3 of subsection (2) substitute "interests" for "interest";
 - (b) in section 59 substitute the following subsection for subsection (2):
"(2) The Minister may make regulations pertaining to the conditions of detention, and matters incidental thereto, of persons detained under section 13."
