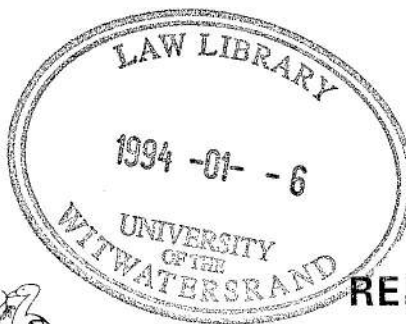
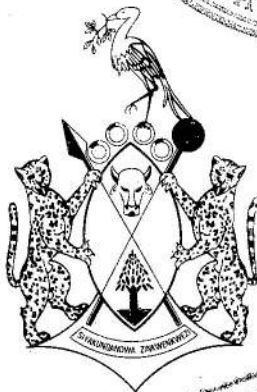

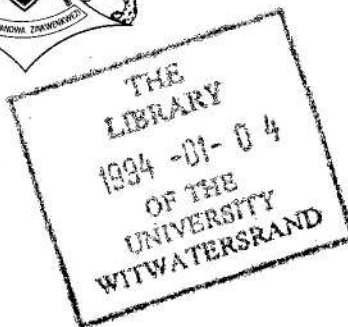

It is hereby notified that the Chairman of the Council of State has assented to the following decree which is hereby published for general information:-

**NATIONAL SECURITY AMENDMENT DECREE, 1993**  
(Decree No. 31 of 1993)

NATIONAL SECURITY AMENDMENT DECREE, 1993

DECREE

To amend the National Security Decree, 1993.

*[English text signed by the Chairman of the Council of State. Assented to on 2 December 1993.]*

BE IT DECREED by the Council of State of the Republic of Ciskei, as follows: -

**1. Amendment of section 13 of Decree 19 of 1993.** - Section 13 of the National Security Decree, 1993 (hereinafter referred to as the principal Decree) is hereby amended -

(a) by the substitution in that part of subsection (1) preceding paragraph (a) for the expression "subsection (10)" of the expression "subsection (8)"; and

(b) by the substitution for paragraph (a) of subsection (1) of the following paragraph:

"(a) has committed or intends or intended to commit an offence referred to in section 2, 3, 4 or 5, excluding (in the case of an offence referred to in section 5) such offence which the suspect committed or intends or intended to commit in connection with a person suspected of having intended to commit or having committed the offence of sabotage, or".

**2. Substitution of section 42 of Decree 19 of 1993.** - The following section is hereby substituted for section 42 of the principal Decree:

"42. Authority of Attorney-General necessary for certain trials. - No trial in respect of an offence under section 2, 3, 4, 5, 28(1), (2) or (3), 29(1), 30(1), 33(1)(d) or (e), 35, 36, 37, 38, 40 or 56(2) shall be commenced without the authority in writing of the Attorney-General."

**3. Amendment of section 43 of Decree 19 of 1993.** - Section 43 of the principal Decree is hereby amended by the substitution for subsection (1) of the following subsection:

"(1) Any act or omission amounting to an offence under section 2, 3, 4, 30, 36, 37 or 55(1) or (2) committed outside the Republic shall be deemed to have been committed at the place where it was actually committed and also at the place where the accused finds himself."

**4. Amendment of section 59 of Decree 19 of 1993.** - Section 59 of the principal Decree is hereby amended by the substitution in subsection (2) for the expression "sections 26, 27 and 28" of the expression "section 13".

**5. Short title.** - This decree shall be called the National Security Amendment Decree, 1993.
