### **AMENDMENT OF SCHEDULE 1 OF THE PUBLIC SERVICE ACT, 1994 (PROCLAMATION No. 103 OF 1994)**

**LIMITATION ON THE ABSTRACTION AND USE OF WATER FOR

KRUGERSDRIFT DAM TO THE CONFLUENCE OF THE RIET RIVER

By virtue of the powers vested in me by section 72(1) read with item 6 of Schedule 3 of the National Water Act, 36 of 1998 :

1. I, Kader Asmal, in my capacity as Minister of Water Affairs and Forestry, hereby declare that a water shortage is being experienced in the area mentioned below.
2. I, direct, with regard to the whole area downstream of the Krugersdrift dam, including the Modder River and the Lower Riet River, down to the confluence of the Riet and Vaal Rivers, that the following restriction of water for irrigation purposes shall apply:
  - 2.1. Abstraction for irrigation purposes within the Riet River and its tributary the Modder River downstream of the Krugersdrift dam, (including the Scholtzburg and Lower Riet River Irrigation Districts) must be curtailed to 35% of the full quota delivered from the Krugersdrift Dam.
3. I hereby assign in terms of section 75(1)(b) of the said Act, to the Regional Director: Free State and the Regional Director: Northern Cape, Department of Water Affairs and Forestry the power to, by notice in the *Government Gazette*
  - 3.1. amend with their discretion the provisions of this notice in general or in respect on any particular area or person in order to accomplish, with due regard to local conditions, the required curtailment; or
  - 3.2. with due regard to a deterioration or improvement in the availability of water in the Krugersdrift dam -

- (a) extend or relax the envisaged curtailment or, as the case may be, to lift it indefinitely, in which case this notice shall be deemed to have been revoked by me; or
- (b) temporarily take over the operation of and privately owned water works by means of which water to which this notice applies, is abstracted, impounded, stored, supplied or used for irrigation purposes and to cause the operation of such a water work to be undertaken in accordance with their directions by any person designated in writing by them.

**ABOLITION OF CERTAIN TITLE CONDITIONS BILL, 1999**

In terms of the Rules of the National Assembly notice is hereby given that the Minister of Land Affairs intends to introduce the Abolition of Certain Title Conditions Bill, 1999, in the National Assembly.

The Bill will provide for the abolition of certain conditions in terms of which the consent or permission of the holder of an office under the Republic, the former Union of South Africa or any of its constituent colonies or republics, is required for the alienation or transfer of immovable property from one person to another.

The Department of Land Affairs has received numerous requests from the public and from local authorities for the Minister of Land Affairs either to give consent to the transfer of land which is subject to a restrictive title condition in favour of the State, or to consent to the cancellation of the condition itself.

In terms of these conditions, the consent of the President (or one of his predecessors such as the Governor-General) or the Minister is required to consent to the alienation or transfer of a piece of land from one person to another. Examples of such conditions are:

“that the land hereby granted or any part thereof shall not be transferred to any owner or owners thereof except with the permission in writing of the Governor of Natal” and

“that the land hereby granted shall not be alienated or transferred to any person unless the consent of the Governor-General shall have been first had and obtained”.

In relation to some of the enquiries it is also not clear whether the Minister of Land Affairs is in law the competent authority to grant such consent. In many cases it is virtually impossible to establish who is the current successor to the functionary mentioned in the title deed (eg. the Governor of Natal). This not only involves a lot of time consuming research, but also creates legal uncertainty.

In certain categories of cases, the requirement of consent is no more than the relic of an historical situation which is no longer relevant. In these cases, the granting of consent is a pure technicality. However, complying with this technicality takes a good deal of time of staff in the Departments concerned, and delays development and use of the land. This Bill has thus been prepared to provide for the abolition of those types of conditions.

The intention is not to derogate from other legislation making provision for the cancellation, amendment or suspension of conditions, such as the Removal of Restrictions Act, 1967 (Act No. 84 of 1967), or section 2A of the State Land Disposal Act, 1961 (Act No. 48 of 1961), hence the need for certain exclusions. These address



conditions regarding the change of land use, town planning scheme restrictions, rights to minerals, periods during which land may not be alienated or transferred, and rights of resumption by the State (in which cases the consent or permission of the President or relevant Minister must still be obtained).

The Bill does not in any way affect the usual requirement that land can not be transferred without the consent of the registered owner. In those cases where the Minister of Land Affairs holds land registered in the name of the State (eg. former SADT land or state land in the former homelands) or where he or she is the nominal owner of land (eg. land held in trust for a community or tribe), the consent or permission of the Minister will still be required for the alienation or transfer of such land. The same applies to land owned by the State through other Departments, eg. Department of Public Works.

The Department of Land Affairs consulted with the Chief Registrar of Deeds, the Department of Agriculture, the Department of Housing, the Department of Public Works and the Department of Water Affairs and Forestry in the preparation of the Bill.

The Bill does not contain any implications for a province or a municipality.

**WETSONTWERP OP DIE AFSKAFFING VAN SEKERE TITELVOORWAARDES, 1999**

Kragtens die Reëls van die Nasionale Vergadering word hierby kennis gegee dat die Minister van Grondsake voornemens is om die Wetsontwerp op die Afskaffing van Sekere Titelvoorwaardes, 1999, by die Nasionale Vergadering in te dien.

Die Wetsontwerp sal voorsiening maak vir die afskaffing van sekere voorwaardes ingevolge waarvan die toestemming of goedkeuring van 'n ampsbeker van die Republiek, die eertydse Unie van Suid-Afrika of enige van sy konstituerende kolonies of republieke vereis word vir die vervreemding of oordrag van onroerende eiendom van een persoon aan 'n ander.

Die Departement van Grondsake het heelwat versoeke ontvang van die publiek en plaaslike owerhede dat die Minister van Grondsake of toestem tot die oordrag van grond wat onderhewig is aan 'n beperkende titelvoorwaarde ten gunste van die Staat, of toestem tot die kansellering van die voorwaarde as sulks.

Ingevolge hierdie voorwaardes word die toestemming van die President (of een van sy voorgangers soos die Goewerneur-generaal) of die Minister vereis vir die vervreemding of oordrag van 'n stuk grond van een persoon aan 'n ander. Voorbeelde van sodanige voorwaardes is:

"dat die grond hiermee toegeken of enige deel daarvan nie oorgedra sal word aan enige eienaar of eienaars daarvan nie tensy met die skriftelike toestemming van die Goewerneur van Natal" en

"dat die grond hiermee toegeken nie vervreem sal word of oorgedra sal word aan enige persoon nie tensy die toestemming van die Goewerneur-generaal eers gekry en verkry is".

In sommige van die navrae is dit ook nie duidelik of die Minister van Grondsake regtens die bevoegde gesag is om sodanige toestemming te gee nie. In baie gevalle is dit feitlik onmoontlik om vas te stel wie is die huidige opvolger van die funksionaris wat in die titelbewys vermeld word (bv. Goewerneur van Natal). Dit behels nie slegs baie tydrowende navorsing nie, maar skep ook regsonsekerheid.

In sekere kategorieë gevalle is die vereiste van toestemming niks meer as 'n oorblyfsel van 'n historiese situasie wat nie meer van belang is nie. In sulke gevalle is die toestaan van toestemming 'n blote formaliteit. Nakoming van hiedie tegiese besonderheid neem egter baie tyd in beslag en vertraag die ontwikkeling en gebruik van die grond. Die Wetsontwerp is derhalwe voorberei om voorsiening te maak vir die afskaffing van daardie soort voorwaardes.

Die voorneme is nie om inbreuk te maak op ander wetgewing wat voorsiening maak vir die kansellering, wysiging of opheffing van voorwaardes, soos die Wet op die Opheffing van Beperkings, 1967 (Wet No. 84 van 1967), of artikel 2A van die Wet op die

Beskikking van Staatsgrond, 1961 (Wet No. 48 van 1961), nie, en is sekere uitsluitings derhalwe nodig. Dit uitsluitings reël voorwaardes betreffende die verandering in grondgebruik, beperkings op dorpsbeplanningskemas, regte op minerale, tydperke waarbinne grond nie vervreem of oorgedra mag word nie en regte van opname deur die Staat (in welke gevalle toestemming of goedkeuring deur die President of die betrokke Minister steeds verkry moet word).

Die Wetsontwerp beïnvloed op geen wyse die normale vereiste dat grond nie oorgedra kan word sonder die toestemming van die geregistreerde eienaar nie. In daardie gevalle waar die Minister van Grondsake grond geregistreer in die naam van die Staat hou (bv. voormalige SAOT-grond of staatsgrond in die voormalige tuislande) of waar hy of sy die nominale eienaar is van grond (bv. grond wat in trust gehou word vir 'n gemeenskap of 'n stam), word die Minister se toestemming en goedkeuring nog steeds vereis vir die vervreemding of oordrag van sodanige grond. Dieselfde is van toepassing op grond in besit van die Staat deur ander Departemente soos bv. die Department van Openbare Werke.

Die Departement van Grondsake het die Hoofregistrator van Aktes, die Departement van Landbou, die Departement van Behuising, die Departement van Openbare Werke en die Departement van Waterwese en Bosbou in die voorbereiding van die Wetsontwerp geraadpleeg.
