**EXTENSION OF THE CLOSING DATE FOR WRITTEN
REPRESENTATIONS ON THE DRAFT FINDINGS DOCUMENT IN THE
INQUIRY INTO SUBSCRIPTION TELEVISION BROADCASTING
SERVICES**

1. The Independent Communications Authority of South Africa (“the Authority”) published the Draft Findings Document pursuant to the Inquiry into Subscription Television Broadcasting Services in terms of section 4B of the ICASA Act, read with section 67(4) of the ECA in Government Gazette No. 42391 of 12 April 2019, calling upon interested parties to make written representations on the Draft Findings Document within 45 days of its publication i.e. by 21 June 2019.
2. On 2 May 2019, the Authority received correspondence from a stakeholder requesting the Authority to furnish it with the underlying information, research and/or documents which form the basis of the Authority’s preliminary conclusions set out in the Draft Findings Document (“**the Underlying Information**”). The stakeholder also

requested that the closing date for written representations be extended by 60 days from the date on which the Underlying Information is provided.

3. The Authority has considered and decided to grant the above request.
4. On 31 May 2019 the Authority uploaded the aforementioned correspondence and the Underlying Information onto its website for access by all interested parties.
5. The closing date is hereby extended by 60 days from 21 June 2019 to 27 August 2019 at 16h00.
