## NOTICE

**Determination of Nominating Bodies**

The Rules for the Procedure for the Nomination of Council Members, requires that the Engineering Council of South Africa, in consultation with the Council for the Built Environment, determine Nominating Bodies who will be invited to submit nominations for council members.

The Minister needs to appoint 50 persons to the Council, therefore nominations received from respective Nominating Bodies together with other nominations received, will be submitted to the Minister of Public Works for consideration and appointment.

The criteria for Nominating Bodies in terms of Rule 5.4.2 are:

*“Prescribed Nominating Bodies are organisations with a sound knowledge of the circumstances under which engineering projects and products are delivered, operated and maintained by persons registered under the Act; and relating in particular to having a sound understanding of the effects on members of society who are the end users of these projects, products and services. Such organisations shall be considered for determination in terms of section 3(2) of the Act as a Nominating Body.*

*Such organisations shall comply with one of the following criteria:*

- (i) Be an employer of registered persons;*
- (ii) Be an organisation that upon application to the Council shows interest in the engineering profession;*
- (iii) Be a body representing institutions of higher education”*

As you were identified as a Nominating Body you are cordially invited to apply for inclusion by no later than Monday the 22<sup>nd</sup> of July 2019 at 16h00, by completing the attached application form.
