**LABOUR RELATIONS ACT, 1995****NOTICE OF INTENTION TO CANCEL THE REGISTRATION OF TRADE UNION**

I, **Lehlohonolo Daniel Molefe**, Registrar of Labour Relations, hereby, in terms of section 106(2B) give notice of my intention to cancel the registration of **Democratic Municipal and Allied Workers Union of South Africa (DEMAWUSA)**(LR2/6/2/2420) for the following reason:

- The union failed to comply with the provisions of section 99 and 100 of the Act
- The Union failed to comply with Guidelines for balloting regarding members having a secret ballot before embarking on a strike action.

The union and all interested parties are hereby invited to make written representations as to why the registration should not be cancelled. **Only representations pertaining to this Notice will be considered. All correspondence should refer to case number: 2019/299.**
