

SCHEDULE

Definition

1. In this Schedule "the Regulations" means the Regulations published by Government Notice No. R. 400 of 28 March 2002, and as amended by Government Notice No. 536 of 23 April 2004, Government Notice No. R. 823 of 10 August 2005, Government Notice No. R. 948 of 5 October 2009 and Government Notice No. R. 1434 of 28 December 2018.

Amendment of regulation 1 of the Regulations

2. Regulation 1 of the Regulations is hereby amended by the substitution for the definition "identity document" of the following definition:
"identity document" means a 13 digit bar-coded RSA identity document and or an RSA bar-coded passport, and includes valid foreign identity documents and passports, as well as permits and other identifying documents contemplated in or issued in terms of the Refugees Act, 1998 (Act No.130 of 1998);".

Short title

3. These Regulations are called the Unemployment Insurance Amendment Regulations, 2019.

Commencement

4. These Regulations shall come into operation on the date of publication hereof.


