The existing 12 MW Lusiwasi Hydro Power Station is located on the Lusiwasi River where it descends the Muchinga Escarpment approximately 80km east of the town of Serenje in Central Province. The Station was constructed in stages with the initial constructed between 1967 and 1971 with an installed capacity of 2 x 3 MW Turbine Generator Units and subsequently extended with an additional 2 x 3 MW Turbine Generator Units commissioned in 1974. The current 12 MW scheme includes Lake Lusiwasi storage dam and Lusiwasi Hydro Power Station located approximately 50km downstream. The Hydro Power Station comprises a river diversion weir and canal intake from which water flows through the canal approximately 1600m to a forebay and penstock intake. From the forebay and intake, two steel penstocks convey the water down the Escarpment to the power house.
