1.3 *Grade Three - Satisfactory (45%-59%)*

Institutions with a mixture of strengths and weaknesses in the above-named quality elements. They barely meet the minimum training standards.

1.4 Institutions graded below Grade Three are not registered and are not allowed to offer any training activities

2.0 *Level*

This is the highest level of training an institution is authorised to provide.
