1. That companies/employers award a 100% once off hardship allowance for the period 1st April, 2020 to 30th June, 2020, which is equivalent to the total of the employee’s basic salary, transport allowance and housing allowance based on March 2020 company remuneration level to be paid in June 2020.
2. That companies/employers to remit NEC levies from this allowance mentioned in clause 1 above.
3. That with effect from 1st July, 2020 to 30th September, 2020, companies/employers in the Insurance and Pensions Industry effect a 155% increase on basic minimum salary on all NEC grades as per table 1.

Collective Bargaining Agreement: Insurance and Pensions Industry

4. That with effect from 1st July, 2020 to 30th September, 2020, companies/employers in the Insurance and Pensions Industry award a minimum housing allowance of \$1 250,00, for each NEC graded employee.
5. That with effect from 1st July, 2020 to 30th September, 2020, companies/employers in the Insurance and Pensions Industry continue to pay a minimum transport allowance of \$889,00, for each NEC graded employee.
6. That companies/employers who are able to pay more are encouraged to do so and to advise the NEC of such awards.
7. Companies/employers that are not able to comply with this CBA should apply for exemption to the NECIPI Exemption Committee within a month from the date of this agreement. Such applications should be accompanied by appropriate and relevant financial statements.
8. That companies/employers are reminded to remit NEC levies as required in terms of Statutory Instrument 146 of 2016.
