**Brief Description:** Expression of Interest for Engagement of a Consulting Firm to undertake Architectural Consultancy Services at Kanyemba Lodges at the Banks of Zambezi River, Mbire District, Mashonaland Central.

**Section I**

**1. Background and Rationale**

Kanyemba, situated 439 kilometres North of Harare on the banks of Zambezi River, is a focal point for fishing and hunting activities in the nearby Dande Safari Area. It is also the endpoint for long-haul canoe safaris along the Zambezi River starting from Chirundu or Mana Pools. It has been described as Zimbabwe's newest town under construction, as the Government sets out to develop Kanyemba into a place of history, commerce, industry, and trade. These plans have seen the inclusion of Kanyemba in the Government's National Irrigation Plan which targets the establishment of 350,000ha under irrigation across the country. In this plan, a total of 10,000ha of land will be cleared for irrigation in Kanyemba setting the pace for the development of Kanyemba as an agriculture hub as well as the already existing tourism activities. In line with this grand plan

to develop Kanyemba, the Bank has set aside a budget to develop Kanyemba Lodges and Conference Centre on the current lodges site as well as on the additional land acquired. The Bank has a 36% shareholding in Kanyemba Zambezi Lodges with Mr. Garry Dalkin owning 64%.

The lodges at Kanyemba were gutted by fire in 2011 with four (4) of the lodges reduced to shells. The lodges consist of a double storey main building, six (6) chalets which can be renovated, four (4) burnt chalets, a burnt generator house, staff quarters and a fuel station.

## 2. Objectives of the Study

The primary objective of this consultancy assignment is to provide architectural consultancy services for the refurbishment of Kanyemba Lodges in Mbire District, Mashonaland Central.

## 3. Scope of Services

The scope of work of the Consultancy services shall include, but not be limited to, the following activities over a period of 14 days:

- i. Site assessment.
- ii. There are no designs for the burnt structures at site. In this regard, the Consultant shall review existing as built designs from site observations and develop and recommend new alternative designs to the Client as follows.
  - a. Prepare preliminary architectural working drawings, which shall show the general layout and the design of the lodges.
  - b. Submit for Client's approval.
- iii. Obtain design approvals from the relevant local authority.
- iv. Prepare bills of quantities and cost estimates for the construction of the lodges.

## Section II

## Conditions of Acceptance of Copy

FAILURE to comply with any of the following conditions will result in the rejection of copy, and no responsibility can be accepted if such rejection should affect any date contained in such copy or any requirement of publication on a specific date.

Persons drafting any kind of notices are strongly advised to follow the guidance offered in—

- (a) the Instructions Relating to the Drafting and Typing of Legislation (Attorney-General's Circular 1 of 1978); and
- (b) the Manual of Style for the Drafting and Preparation of copy published by Printflow (Private) Limited;

which two booklets are intended for complementary use.

In these conditions, other than where a particular kind of copy is specified, "copy" means copy for all matter contained in the *Gazette*

itself and for subsidiary legislation issued as supplements to the *Gazette*.

1. (1) Other than by prior arrangements, only original typing is accepted.

(2) Carbon-copies are not normally acceptable, other than in cases where the original typing has to be legally retained, elsewhere, as, for example, in the case of a proclamation.

2. (1) All copy must be clear and legible, and there must be double or one and a half spacing between the lines.

(2) Any corrections or alterations made by the originator, must be clearly effected in blue or black ink, using editorial marks—not proof-reader's marks:

Provided that any copy containing extensive alterations will be rejected.

3. (1) Copy must appear on one side only of each sheet of paper.

(2) Except as is provided in subsection (2) of section 8, paper must not exceed 210 millimetres in width.

(3) If copy comprises two or more sheets of paper, all sheets must be numbered consecutively, in arabic figures, preferably in the top right-hand corner.

(4) Where any matter is added after the copy has been prepared, and such additional matter results in one or more sheets being inserted between those already numbered, all sheets must be renumbered from there onwards—not, for instance 7, 7b, 8, *et cetera*.

4. Photographic copy or copy produced on a duplicating machine may be accepted if it is abundantly clear.

5. (1) Should any copy—

- (a) exceed 10 pages of double-spaced typing on size A4 paper; or
- (b) contain tabular or other matter which involves complicated setting; it will be classed as "lengthy" copy, and will be required to be submitted not less than 21 days before the date of closing for the *Gazette* in which it is to be published.

(2) Lengthy copy may be accepted at less than 21 days' notice if—

- (a) the work involved is of a straight forward and non-tabular nature; and
- (b) the total volume of work on hand for the time being permits its acceptance.

6. Notwithstanding anything to the contrary contained in these conditions, any copy—

Officers of Parliament (Terms of Service) (Amendment)  
Regulations 2021, (No. 1)

IT is hereby notified that pursuant to section 154(5) of the Constitution, the Committee on Standing Rules and Orders has made the following regulations: —

1. These regulations may be cited as the Officers of Parliament (Terms of Service) (Amendment) Regulations, 2021, (No. 1).

2. The Officers of Parliament (Terms of Service) Regulations, 2018, published in Statutory Instrument 24 of 2018, are amended in section 30 (‘Retirement on reaching pensionable age’) by the repeal of subsection (1) and the substitution of the following—

“(1) Mandatory retirement on reaching pensionable age shall be sixty-five years.”.
